1.13 Swimming Pools

The construction, installation, maintenance, or repair of all types of in ground swimming pools, whirlpools, water features and fountains and all associated components. Swimming pools is a subclassification of Building Construction.

Introduction



Swimming Pools is a closed book examination with 50 multiple-choice questions and a minimum passing score of 70. You will have **two hours** to complete this examination.
