### **7-67 Wharves, Docks, Harbor Improvements, and Terminals**

#### *Classification Description*

*Refers to the construction, maintenance or repair of navigation vessels including barges, riverboat casinos and shipyards as well as wharves, docks, and related terminals, piers, waterfront pile driving and related equipment, dolphins, breakwaters, revetments, bulkheads, seawalls, retaining walls, cofferdams, caissons, underwater welding, marine diving and salvaging, underwater construction, and related dredging and draglines for harbors and other construction in navigable waterways.*

# Introduction



*Wharves, Docks, Harbor Improvements, and Terminals* is a *closed book* examination with 50 multiple-choice questions and a minimum passing score of 70. You will have **two hours** to complete this examination.
